ZipMilk is a site that provides listings for chest/breastfeeding resources sorted by **ZIP Code**. This was designed for use by consumers wanting to help or support breastfeeding, as well as providing resources to clients.

The data is collected by the Missouri Breastfeeding Coalition and the Department of Health and Senior Services (DHSS). Data verification takes place at least once a year with each organization.

Joining ZipMilk is easy and free! If you want to submit a resource/listing, you must classify in one of the following categories:

- Breastfeeding Counselors/Educators
- Free Community Breastfeeding Support Counselors
- IBCLC
- Medical Professional
- Support Group
- WIC Breastfeeding Support

**Community-Based Suicide Prevention for Local Health Departments**

With support from the Centers of Disease Control and Prevention, the National Association of County and City Health Officials is launching a new NACCHO University course: Community-Based Suicide Prevention for Local Health Departments. This free, 4-module online course aims to help local health departments implement community-based suicide prevention and advance the 2024 National Strategy for Suicide Prevention. The two-hour course will help learners apply this key resource in four distinct areas:

- Module 1: Building and Sustaining Cross-Sector Suicide Prevention Partners
- Module 2: Support Upstream Comprehensive Suicide Prevention
- Module 3: Promoting Lethal Means Safety
- Module 4: Organizing Response & Support After Suicide Attempts and Loss
