## **UPDATES**

Message from Director Willson (5/12/2025)

**CORE Funding:** Lori Brenneke provided an update on funding specific to CORE LPHA contracts on the LPHA Update call May 13. A copy of the document she shared is attached. A link to the call recording is posted on the LPHA Hub.

**Measles Update:** DHSS OPI is working to develop a press release that will answer common questions and respond to misperceptions about measles and the MMR vaccine. The release date is not yet scheduled.

**Enhancing Communication Lunch and Learn**: A recording of the first session (May 14) on "Know Your Audience," along with the slide deck and referenced handouts will be posted on the LPHA Hub this week. Look under the Communication Tools section of the Communications card (use the Communications button in the top menu to jump to this card). The next session will be July 9 at 12:00 pm. Register

<u>Missouri Violent Death Reporting System</u> (MOVDRS) – this new data dashboard provides the public with access to information about suicides and homicides in Missouri, including:

- Demographic breakdowns
- Injury location and mechanism of death
- Manner-specific circumstances
- Mental health & substance misuse circumstances
- Life stressor and crime circumstances
- Toxicology results

Through this CDC-funded grant, MOVDRS partners with law enforcement agencies and coroners/medical examiners across the state to collect information on violent deaths with the goal of providing prevention programs and communities with a clear understanding of the circumstances surrounding such deaths.

**ShowMe World Care updates** tentatively scheduled for May 19 include the following: HAIs, Cyclosporiasis, Adverse Reactions to Vaccinia Vaccination, Acute Flaccid Myelitis (AFM), CJD, Paragonimiasis, Blastomycosis, Histoplasmosis, Coccidioidomycosis, Leprosy, Legionellosis, Pontiac Fever, MERS, SARS, Psittacosis, Ricin, T2 Mycotoxins, Streptococcal Toxic Shock Syndrome, Toxic Shock Syndrome (Other Than Streptococcal), Scabies (Outbreak only), RSV (Outbreak only), Hand/Foot/Mouth Disease (Outbreak only), Bordetella parapertussis (Outbreak only), Staph Enterotoxin B (Outbreak only)

**Workforce Contract Amendments**: With the conclusion of the Workforce Contract June 30, 2025 CLPHS will not be able to process any new amendments, since an amendment can take up to 4 weeks to be fully processed and executed, if there are no issues. CLPHS can still do small budget moves to switch funds into categories that are already on your budget. The budget moves will need to be under 10%, and may vary, depending on if you have moved funds previously. If there is any doubt as to how much you can move please contact CLPHS.

**CORE Contract Invoicing**: In order for DHSS to pay the May 2025 CORE invoices, they must all be submitted to CLPHS (MOPHIRS system) **by June 4, 2025**. They have to be in DHSS's financial department for processing by June 9 to be processed and paid for this fiscal year.
