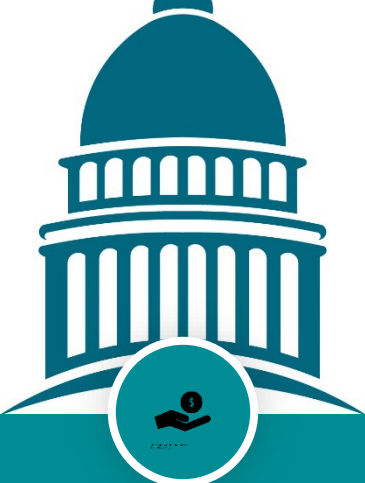

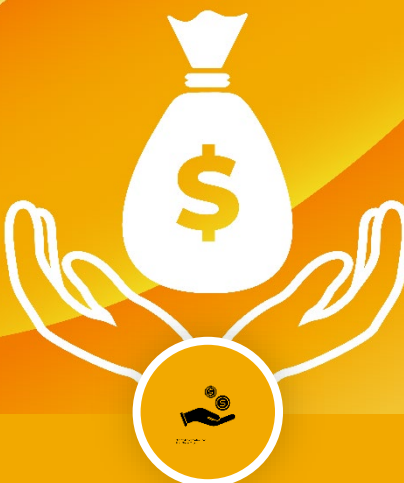

Address gaps in meeting the person's interrelated medical, social, behavioral, educational, informal support system, and financial needs.

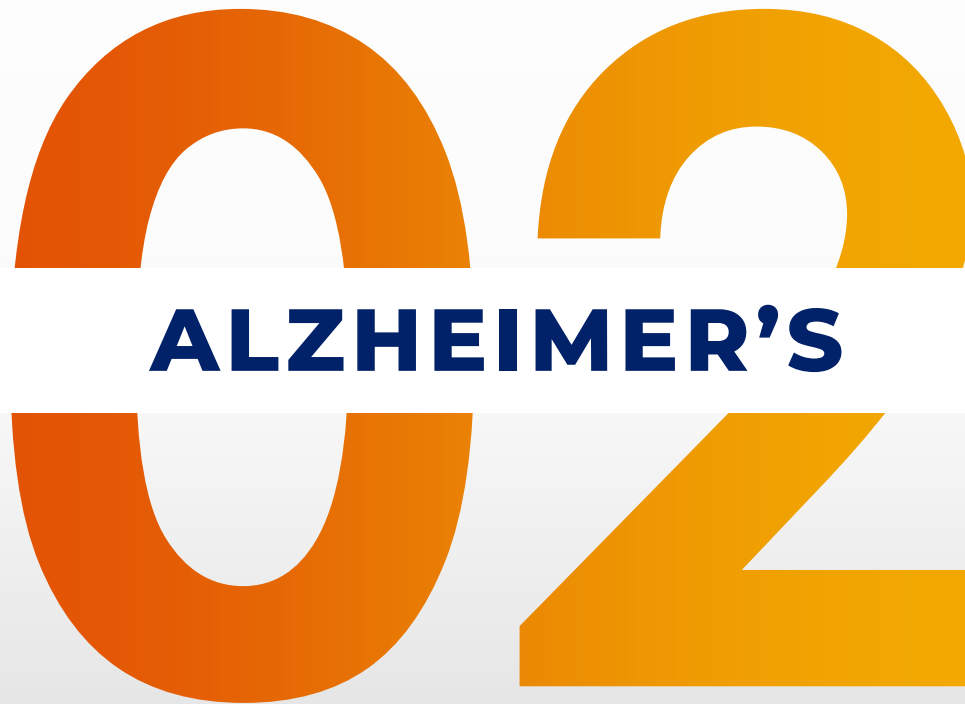
Clinical Care

Symptom management, assistive technology, adaptive equipment, education, care services, and emotional support

Respite Care

Private duty home health assistance that is temporary, substitute supports for care recipients in order to provide a brief period of relief

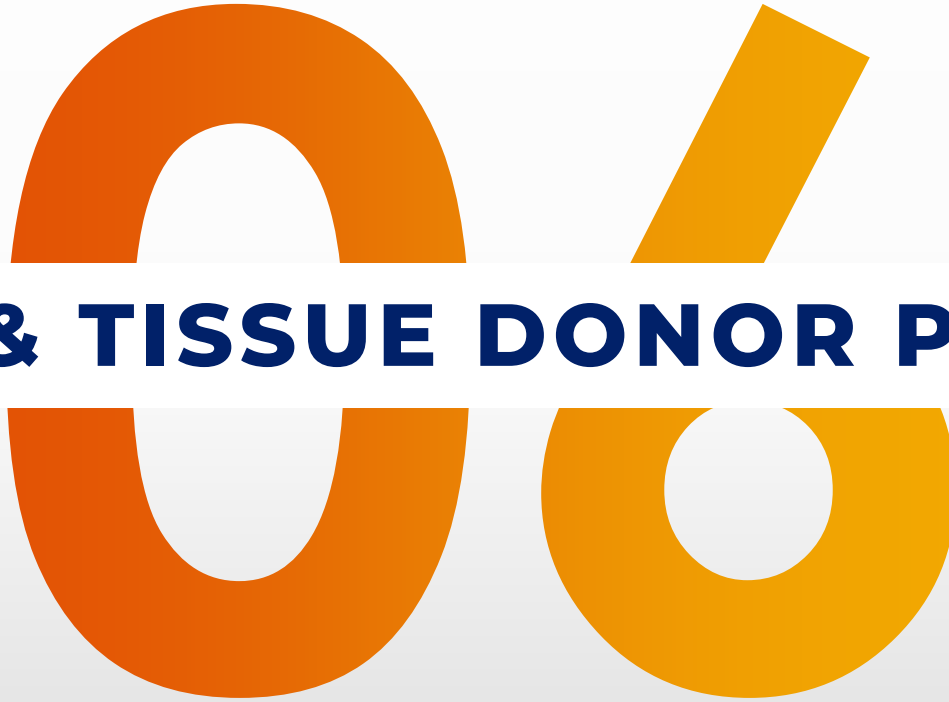
Diabetes : A Strategic Approach to Advancing Health Equity for Priority Populations

Prevent or delay onset of type 2 diabetes among adults with prediabetes and improve self-care practices, quality of care, and early detection of complications among people with diabetes.

Heart Disease: The National Cardiovascular Health Program

Aims to implement and evaluate evidence-based strategies contributing to the prevention and management of cardiovascular disease (CVD) in populations disproportionately at risk.
